

Talking Points for Meetings

1. The goal is to ask you to build a law that bans forced, compelled, coerced, or mandated Digital ID & stable coin/CBDC/programmable money, and to keep cash an option.

2. The problem:

Digital ID is an electronic collection of every physical identity document in one location to prove who we are online or in person without having to produce physical documents, to include driver's license, state ID, passport, social platforms, banking, medical records, mortgage, car, insurance, investments, pensions... Digital ID can be stored on a smart phone in an app or in a Google, Samsung, or Apple wallet. It is sold as a convenience, but it violates our constitutional rights in many ways. It's also a hacker's dream as it is easier to steal an identity that is all one location. It is also a government's greatest tool for controlling its citizens. China uses it now. If citizens step out of line, their bank accounts are frozen or emptied with the click of a button. They're locked out of social media, food stores, online purchasing, travel... Some U.S. states are moving citizens into RealID with no opt-out. Real ID is Digital ID. If your driver's license has a star in the upper right corner, you're in the Digital ID system. Luckily, Wisconsin can still opt-out.

Programmable money refers to CBDC or stable coin. It has logic built into it and rules that govern how, when, where, and to whom money goes. It is different from the digital currency we currently use in credit cards, Zelle, Venmo, or Paypal. We freely choose where, when, and how we use them. Programmable money is connected to Digital ID and controlled by the same click of a button. Accounts can be frozen. A politically incorrect post can freeze a bank account or keep us from travel. We can be forced to buy fake meat if we consume our limit of real meat. If everything we do, purchase, and engage in online is tracked by Digital ID, and everything we transact is done with programmable money, our activity is tracked and freedom and privacy are destroyed. If we ban forced Digital ID, we kill the power of programmable money. You don't have one without the other.

Cash, gold, and silver as Legal Tender: keeping cash in circulation or gold and silver as legal tender is essential to protecting freedom. But, there are reasons other than assets frozen and land grabs: digital currencies get hacked. They fail in severe weather, power outages, or grid failure. Cash, gold, and silver protect freedom, privacy, continuity, and our constitutional rights. They maintain a free society and protect our families during emergencies.

This Bill must:

- 1.** Ban any law that forces, compels, coerces, or mandates Digital ID and programmable money to protect all of us and our children and grandchildren.
- 2.** Ban the federal government from forcing Wi. to adopt all related regulatory actions, rules, laws, or mandates.
- 3.** Include provisions that overrule federal failure to comply with the U.S. Constitution.
- 4.** Oppose any and all bills that violate our state and U.S. Constitution, to include any and all court orders, new rules, laws, or mandates until they comply with our state and U.S. Constitutions.
- 5.** Defend and protect our state legislators and authorities (Sheriffs) in their sworn duty to prevent and protect Wi. citizens from any federal overreach or breach of state or U.S. Constitution in this matter.
- 6.** Block any new law that gives any corporation or business the power or ability to force, compel, coerce, or mandate Digital ID or Programmable Money or adopt any regulatory action, rule, law, or mandate.

Two Questions:

1. Can this be made into an amendment in an existing bill?
2. Which people and committees are the people to bring this to? Time is of the essence and I am happy to meet with people by phone, zoom, or in person. This is rolling out right now across the country and we need to get this passed in the January, February, March 2026 sessions.
